RESOLUTION NO. 605

**A RESOLUTION of the Board of Commissioners of
South King Fire and Rescue (aka KCFPD #39), King County, Washington,
Regarding the Adoption of the IFC Permit Fee Schedule**

WHEREAS, South King Fire & Rescue (SKFR) is a municipal corporation and political subdivision of the State of Washington that has been delegated the authority to perform the fire prevention provisions of the International Fire Code (IFC) within the boundaries of SKFR, by interlocal agreement with the cities of Des Moines and Federal Way and Unincorporated King County; Resolution 605 supersedes and rescinds Resolution 596 and


WHEREAS, the Board of Commissioners considered the cost associated with the dedication of personnel and resources to the work of inspecting, approving and issuing IFC permits; and

WHEREAS, the Board of Commissioners, after considering these costs has decided that applicants for certain permits should bear the costs associated with the issuance of said permits.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of SKFR as follows:

- a. SKFR hereby adopts the following fee schedule for IFC Permits required by the codes adopted by the respective jurisdictions: See the attached Exhibit A, which is incorporated herein by reference.
- b. SKFR reserves the ability to modify the fees set forth in Exhibit A without notice. At any time the fees are modified, a new Exhibit A shall be appended to this resolution and shall supersede the previous Exhibit A.
- c. This resolution shall take effect immediately upon its adoption.





International Fire Code (IFC) Permit Fee Schedule

Appendix A - SKFR Commissioner's Resolution #605

Operational Permit Fee Schedule:

Permit Type	Fee
Compressed gases	\$ 50.00
Carnivals and fairs	\$ 200.00
Covered and open mall buildings	\$ 1000.00
Dry cleaning	\$ 50.00
Explosives	\$ 120.00
Flammable Combustible Liquids: limited to generator fuel tanks	\$ 50.00
Hazardous materials	\$ 132.00
LP gas: no dispensing (heating, generator fuel, exchange)	\$ 50.00
Mobile food preparation vehicles	\$ 120.00
Places of assembly: Occupant load 50-299	\$ 80.00
Places of assembly: Occupant load 300-999	\$ 100.00
Places of assembly: Occupant load 1000+	\$ 120.00
Temporary membrane structures and tents	\$ 100.00
All other permit types	\$ 80.00

Permit fee covers up to ½ hour of plan and/or code review, initial site inspection and one reinspection. Additional plan review time, site visits and/or, additional reinspections to secure compliance are billed at \$73.50/hr. (minimum ½ hour)

Additional permits, of equal or lesser fee, issued to an applicant at the same time and location are reduced by 25%.

An additional third-party payment-processing fee of \$18.50 applies to each invoice

Nonprofit 501(c)(3) Organizations: 50% reduction of permit fees (full payment-processing fee applies)

Construction Permit Fee Schedule:

Permit Type	Fee
Flammable Combustible Liquids (limited to):	
Residential – Install remove or decommission per tank	\$ 50.00
Commercial – Install remove or decommission per tank	\$ 100.00
Temporary membrane structures and tents	\$ 100.00
All other permit types*	\$ 120.00

*This fee schedule excludes permit types issued through the city of Des Moines and Federal Way Building Departments.

Permit fee covers up to ½ hour of plan and/or code review, initial site inspection and one reinspection. Additional plan review time, site visits and/or, additional reinspections to secure compliance are billed at \$73.50/hr. (minimum ½ hour)

An additional third-party payment-processing fee of \$18.50 applies to each invoice
